

ASHOKA UNIVERSITY - FEE STRUCTURE AND REFUND POLICY [August 2021 intake]

COMMENCEMENT DATE OF ACADEMIC SESSION - 23RD AUGUST, 2021

(The commencement date of the academic session is the formally notified last date of admission)

Acceptance Fee and Security Deposits

(To be paid by Round-Wise Acceptance Deadline)

The candidate will be required to deposit an amount of INR 3,31,250 to confirm their offer of admission by the acceptance deadline of the round in which they have applied. This above-given Acceptance Fee amount includes the following:

- Admissions Fee of INR 50,000
- Tuition Fee of INR 2,06,250
- Refundable Security Deposit of INR 50,000
- Refundable Meal Cost Security Deposit of INR 25,000 (One-time payment to be refunded at the time of graduation from Ashoka University or withdrawal of admission)

Semester 1 Fee Deposit

(To be paid by the Round-Wise Semester-1 Fee Payment Deadline)

The candidate will be required to deposit the remaining Semester 1 Tuition Fee and Residence Cost of INR 2,87,250 to ensure that they secure their seat in Ashoka University's Undergraduate Programme for the session commencing on August 23, 2021. This amount includes the following:

- Remaining Semester 1 Tuition Fee of INR 2,06,250
- Semester 1 Residence Cost of INR 81,000

Semester 2 Fee Deposit

(To be paid by mid-January 2022)

The candidate will be required to deposit an amount of INR 4,93,500 toward their Semester 2 Fee. This amount includes the following:

- Semester 2 Tuition Fee of INR 4,12,500
- Semester 2 Residence Cost of 81,000

Please note:

Meals – A minimum amount of INR 17,500 toward meals and dining facilities will be charged at the end of each semester (minimum amount for one year is INR 35,000)



Ashoka University Refund Policy and Amount

Details on Withdrawal of Admission as per University Grants Commission Guidelines

- 1. If a candidate withdraws their admission before or on August 8, 2021 the candidate will receive a refund of the entire Security Deposit of INR 75,000 and a 100% percent refund of the remaining fees paid, less a 5% deduction as administrative processing fee subject to a maximum of INR 5,000 (If withdrawal of admission is 15 days or more before the commencement date of the academic session)
- 2. If a candidate withdraws their admission from August 9, 2021 to August 23, 2021, the candidate will receive a refund of the entire Security Deposit of INR 75,000, and 90% of the remaining fees paid (If withdrawal of admission is less than 15 days before the commencement date of the academic session)
- 3. If a candidate withdraws their admission from August 24, 2021 to September 7, 2021, the candidate will receive a refund of the entire Security Deposit of INR 75,000, and 80% of the remaining fees paid (If withdrawal of admission is 15 days or less after the commencement date of the academic session)
- 4. If a candidate withdraws their admission from September 8, 2021 to September 22, 2021 the candidate will receive a refund of the entire Security Deposit of INR 75,000 and 50% of the remaining fees paid (If withdrawal of admission is 30 days or less, but more than 15 days, after the commencement date of the academic session)
- 5. If a candidate withdraws their admission on or after September 23, 2021, none of the fees paid will be refunded. The candidate will only be refunded the Security Deposit of INR 75,000 (If withdrawal is more than 30 days after the commencement date of the academic session)

Please note the following:

- The above refund details are based on the amount(s) deposited by the candidate within the given payment deadlines of Ashoka University
- The refund amount will differ for candidates based on the amount of financial aid granted to them
- All refunds will happen within 4 weeks from the date of request for withdrawal of admission
- Ashoka University reserves the right to change, modify, add, or remove portions of policy at any time by posting
 the amended policy after taking necessary approvals. Candidates are advised to check policy periodically for
 changes
